What?

How?

How does Harris Marine Financing, Inc protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Harris Marine Financing, Inc collect my personal information? Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Harris Marine Financing, Inc. has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Harris Marine Financing, Inc. does not share with nonaffilitates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Harris Marine Financing, Inc. does not jointly market.
